ORDINANCE NO. 1549

AN ORDINANCE (1) REPEALING SECTION 13-211 OF CHAPTER XIII, ARTICLE 2 OF THE CODE OF THE CITY OF ANDOVER, (2) REPEALING SECTION 13-305 OF CHAPTER XIII, ARTICLE 3 OF SAID CODE, AND (3) REPEALING SECTION 13-405 OF CHAPTER XIII, ARTICLE 4 OF SAID CODE.

WHEREAS, the governing body of the City of Andover, Kansas (the "City") has amended the Code of the City of Andover, Kansas (the "Code"), so as to incorporate by reference the "Uniform Public Offense Code for Kansas Cities" (the "UPOC"), with certain deletions, modifications and additions, as set forth in the Code of the City of Andover, Kansas (the "Code"); and

WHEREAS, the City finds it necessary and desirable to repeal and amend certain provisions of its existing Code which may not otherwise operate in concert with the 2013 Edition of the UPOC (the "2013 UPOC"); and

WHEREAS it is in the best interest of the City (1) to repeal Sections 13-211, 13-305 and 13-405 of the Code.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS AS FOLLOWS:

Section 1. Repeal of Section 13-211. Section 13-211 of Chapter XIII, Article 2 of the Code entitled "Molotov Cocktail" is hereby repealed and deleted from the Code.

Section 2. Repeal of Section 13-305. Section 13-305 of Chapter XIII, Article 3 of the Code entitled "Purchase or Consumption of Liquor or Cereal Malt Beverages by a Minor" is hereby repealed and deleted from the Code.

Section 3. Repeal of Section 13-405. Section 13-405 of Chapter XIII, Article 4 of the Code entitled "Tobacco Products" is hereby repealed and deleted from the Code.

Section 4. Effective Date. This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary of this Ordinance certified as legally accurate and sufficient by the City Attorney.



**Ordinance No. 1549 Summary**

On October 8, 2013, the City of Andover, Kansas adopted Ordinance No. 1549 which repeals Sections 13-211, 13-305 and 13-405 of the Code, which originally established certain public offenses regarding the open carrying of certain explosives, as well as the possession and sale of alcoholic beverages and tobacco products, which offenses are now the subject of the Uniform Public Offense Code for Kansas Cities.
