ORDINANCE NO. 1555

AN ORDINANCE ANNEXING LAND TO THE CITY OF ANDOVER, KANSAS.

WHEREAS, the land described below adjoins the existing boundaries of the City of Andover (the "City") and a written petition for annexation of said land has been signed by each and all owners thereof, and has been filed with the City pursuant to K.S.A. 12-520(a)(7), as amended, and therefore, pursuant to K.S.A. 12-520a(f), no resolution, notice or public hearing are required; and

WHEREAS, the Governing Body of the City hereby finds it advisable to annex all such land.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

Section 1. That the following described land is hereby annexed and made a part of the City of Andover, Kansas:

Lot numbered 4, in Fortney Acres, a subdivision in the Southwest Quarter of Section Numbered 5, Township Numbered 27 South, Range 3 East of the 6th P.M., Butler County, Kansas.


Section 2. Pursuant to K.S.A. 12-522, upon passage and publication of this annexation ordinance, the City Clerk shall file a certified copy of such ordinance with the County Clerk, the Register of Deeds, and the County Election Commissioner, if any, of Butler County.

Section 3. This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary of this Ordinance certified as legally accurate and sufficient by the City Attorney.




