ORDINANCE NO. 1589

AN ORDINANCE CHANGING THE TIME FOR THE REGULAR WORKSHOP MEETING OF THE GOVERNING BODY AND AMENDING SECTION 1-101 OF THE CODE OF THE CITY OF ANDOVER, KANSAS.

WHEREAS, it has been determined by the governing body of the City of Andover, Kansas that it is in the best interest of the City to change the time at which the monthly workshop meeting shall commence.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

Section 1. Section 1-101 of the Code of the City of Andover, Kansas, shall be amended to read as follows:

1-101. **Governing Body Meeting.** The regular meetings of the Governing Body of the City of Andover, Kansas shall be held semi-monthly on the second and last Tuesday of each month, in the Council Chambers in the City Hall of Andover, Kansas, commencing at 7:00 p.m. In addition to the foregoing regular meetings there shall also be a monthly workshop meeting on the last Monday before the last Tuesday of each month, which meeting shall be at the Central Park Lodge and which shall commence at 6:00 p.m. The Council shall be permitted to conduct any business which comes before it during any one of the three regular meetings established herein with the primary purpose of the workshop meeting being to provide the Council with a regular time during which to discuss and establish policy and to devote its attention to issues requiring in-depth analysis.

Section 2. This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.
