ORDINANCE NO. 1608

AN ORDINANCE ESTABLISHING CERTAIN COURT COSTS WITHIN THE CITY OF ANDOVER, KANSAS; AND AMENDING CHAPTER X, ARTICLE 1, SECTION 10-106 OF THE CODE OF THE CITY OF ANDOVER, KANSAS.

WHEREAS, the governing body of the City of Andover, Kansas (the "City") desires to amend the Code of the City of Andover, Kansas (the "Code") to increase certain charges of the Municipal Court in and for the City, as part of its ongoing administration of justice; and

WHEREAS, the governing body of the City finds it necessary and advisable to amend Section 10-106 of Chapter X, Article 1 of the Code.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. The City hereby amends Section 10-106 of the Code to read, as follows:

10-106. Court costs.

In each case, with the exception of parking violations and seatbelt violations, brought in the Municipal Court of Andover, Kansas, there shall be costs assessed to such party as the Court shall designate to defray the administrative expenses incurred therein. Costs shall be fixed in the amount of \$90.00 per case filed which shall generally be inclusive of the fees and assessments imposed by the State of Kansas. The following additional costs shall be imposed by the Court, when necessary or applicable:

- (a) \$20.00 fingerprinting fee;
- (b) \$35.00 prisoner care fee (per chargeable day of incarceration).

In addition to the foregoing fixed costs, the following additional costs may be imposed by the Court:

- (c) \$25.00 warrant service fee;
- (d) \$.30 per mile for warrant service;
- (e) \$10.00 witness fee (per person);
- (f) \$.30 per mile paid for witnesses under subpoena.

In addition to all the foregoing costs, court costs may also include such additional amounts as may be necessary to be spent to compel the attendance of witnesses, for laboratory analysis, and for any other expenses, as determined within the discretion of the Court as reasonably necessary for the proper administration of justice.

SECTION 2. This Ordinance shall take effect January 1, 2016 after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.
