ORDINANCE NO. 1618

AN ORDINANCE ANNEXING LAND TO THE CITY OF ANDOVER,
KANSAS.

WHEREAS, each tract contained within the real property described below (the “Property”) lies within or mainly within the City of Andover, Kansas (the “City”) and has a common perimeter with the City boundary line of more than 50%; and

WHEREAS, pursuant to K.S.A. 12-520(a)(4) and 12-520a the City adopted Resolution No. 16-09 (the “Resolution of Intent”) on April 12, 2016 indicating its intent to annex the Property and setting a public hearing to consider such annexation to be held on June 14, 2016 at 7:00 p.m., or as soon thereafter as practicable, at Andover City Hall, 1609 E. Central Ave., Andover, Kansas 67002; and

WHEREAS, the City established a plan for the extension of services to the Property (the “Plan”), as required by K.S.A. 12-520b, and amendments thereto, and made it available for inspection during regular office hours in the office of the City Clerk at Andover City Hall, 1609 E. Central Ave., Andover, Kansas 67002; and

WHEREAS, the City (i) mailed a certified copy of the Resolution of Intent, together with a map of the Property, by certified mail to (a) each owner of land within the Property, (b) the board of county commissioners, (c) the governing body of the township where the Property is located, (d) all special assessment districts or governmental units providing municipal services to the Property, (e) all utilities having facilities on the Property, (f) the governing body of all school districts in which the Property is located, (g) all cities, counties, townships, and joint planning commissions having jurisdiction over the Property, (h) all other political or taxing subdivisions in which the Property is located, all on April 22, 2016, said date being not more than 10 days following the date of adoption of the Resolution of Intent, (ii) caused the Resolution of Intent, together with a map of the Property, to be published in *The Butler County Times-Gazette* on June 7, 2016, said date being not less than one week and not more than two weeks prior to the date fixed for the public hearing, and (iii) mailed a copy of the Plan to the Board of County Commissioners of Butler County, Kansas by certified mail, return receipt requested on June 3, 2016, said date being not less than 10 days prior to the date of the public hearing; and

WHEREAS, having held the public hearing as required by K.S.A. 12-520a and the Resolution of Intent, the Governing Body of the City hereby finds it advisable to annex all of the Property.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following described land is hereby annexed and made a part of the City of Andover, Kansas:

The Northwest Quarter of the Northeast Quarter of Section 30, Township 27 South, Range 3 East of the 6th Principal Meridian, Butler County, Kansas except for existing highway right of way along the north line of said tract, said right of way being situated within the corporate limits of the City of Andover, Butler County, Kansas, and except the road right of way known as Frey Street.

(the “Property”).

SECTION 2. Pursuant to K.S.A. 12-522, upon passage and publication of this annexation ordinance, the City Clerk shall file a certified copy of such ordinance with the County Clerk, the Register of Deeds, and the County Election Commissioner, if any, of Butler County.

SECTION 3. If any provision of this Ordinance shall be held or deemed to be invalid, inoperative or unenforceable as applied in any particular case, to any particular portion, tract, or land included in the Property, or in any case because it conflicts with any other provision or provisions hereof or any constitution or statute or rule of public policy, or for any other reason, such circumstances shall not have the effect of rendering the provision in question inoperative or unenforceable in any other case, as applied to any other portion, tract, or land included in the Property, or circumstance, or of rendering any other provision or provisions herein contained invalid, inoperative or unenforceable to any extent whatsoever.

SECTION 4. This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary of this Ordinance certified as legally accurate and sufficient by the City Attorney.
