ORDINANCE NO. 1545

AN ORDINANCE AMENDING THE CODE OF THE CITY OF ANDOVER, KANSAS, CHAPTER VII, FIRE PROTECTION, ARTICLE 1, FIRE CODE OF THE CITY OF ANDOVER, SECTION 7-103 AMENDMENTS (2003 EDITION OF THE INTERNATIONAL FIRE CODE)

WHEREAS, it has been determined to be in the best public interest to limit the location of open burning and trash burning within the City limits of the City of Andover, Kansas.

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the City of Andover, Kansas as follows:

SECTION 1: Chapter VII, Article 1, Section 7-103 of the Code of the City of Andover, Kansas is hereby amended to include the following provision:

ARTICLE 1: 7-103. AMENDMENTS

(aa) Section 307.3 is amended as follows: LOCATION The location for open burning shall not be less than fifty (50) feet (15240mm) from any structure or property line, and provisions shall be made to prevent the fire from spreading to within fifty (50) feet (15240mm) of any structure or property line.

SECTION 2: This Ordinance shall take effect and be in full force after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.


