ORDINANCE NO. 1546

AN ORDINANCE AMENDING THE CODE OF THE CITY OF ANDOVER, KANSAS, CHAPTER XV, REFUSE AND TRASH, ARTICLE 1, REFUSE AND TRASH; SOLID WASTE, SECTION 15-116, BURNING TRASH AND GARBAGE.

WHEREAS, it has been determined to be in the best public interest to limit the volume and location of open burning and trash burning within the City limits of the City of Andover, Kansas.

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the City of Andover, Kansas as follows:

SECTION 1: Chapter XV, Article 1, Section 15-116 of the Code of the City of Andover, Kansas is hereby amended and replaced to read:

ARTICLE 1: 15-116 BURNING TRASH AND GARBAGE

- (a) It shall be unlawful for any person to burn or cause to be burned in the City of Andover, Kansas, any material which upon burning may emit obnoxious odors or smoke. It shall also be unlawful for any person to burn any material within the City of Andover, Kansas, without a valid open burning permit issued under Chapter VII, Fire Protection, Article 1, of the Code of the City of Andover.
- (b) Violation of this Ordinance shall be subject to a fine not to exceed \$500.

SECTION 2: This Ordinance shall take effect and be in full force sixty (60) days from and after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.
